**Non –Food Vendor Contract**

At all times hereinafter, the relationship between Licensee and Pucho, Inc. shall be that of Licensee and Licensor, and nothing shall construe the relationship to be otherwise.

For the fees as set forth below, Pucho, Inc. agrees to license a certain portion of festival premises to Licensee as specifically set forth and assigned by Pucho, Inc. for a concession stand under the following conditions.

Event: Annual Grease Pole Festival

Fee: \$200 – Small Vendor, Entire Festival  
\$400 – Large Vendor, Entire Festival  
\$100 – Small Vendor, Per Day  
\$150 – Large Vendor, Per Day  
\$50 – Non Profit Display Table Per Day  
\$100 – For Profit Display Table Per Day

(All fees include the City of Buffalo special Events Application Fee)

Regulations:

1. No Licensee may sell liquor or beer at any time during the event; to do so will void this contract and no refund will be given
2. No Licensee may sell food, beverages, snacks any time during the event; to do so will void this contract and no refund will be given
3. Pucho, Inc. will provide Tent, Table and Chairs
4. Licensee must provide any other equipment necessary
5. Set-up for each stand must be completed by 5pm on Friday
6. Each stand must provide their own electrical extension cords and lights. Electrical cords must be heavy duty.
7. Pucho, Inc. will provide overnight security for all stands during the event.
8. Licensee must remove all contents no later than 11pm on Sunday.
9. Pucho, Inc. assumes no responsibility for stands, equipment, materials and/or supplies from 8am to 12am
10. Event will end at 9pm on Sunday
11. Pucho, Inc. is not liable for any refund of fees should circumstances beyond Pucho, Inc. control causes the discontinuation of any portion of the festival; this is to include but is not limited to Weather, fights, law enforcement requests or others.
12. Pucho, Inc. reserves the right to designate Licensee's licensed portion of space
13. Licensee unconditionally agrees to abide by any additional reasonable requests made by Pucho, Inc. Festival Committee Members
14. Pucho, Inc. reserves the right to refuse licensure to any party or modify or terminate this agreement if deemed necessary
15. Failure to abide by any part of this agreement will result in immediate revocation of license to operate on festival grounds
16. Should Licensee for any reason commence legal action against Pucho, Inc. it's Board of Directors, Advisory Board, volunteers, employed, etc. licensee shall be liable to said parties for reasonable attorney's fees, lost wages, and cost of litigation should licensee not prevail in said court action.
